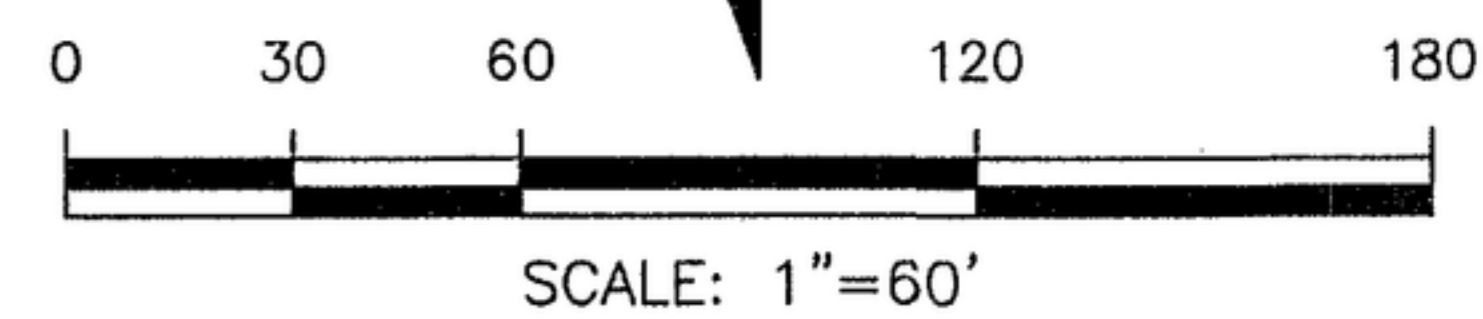
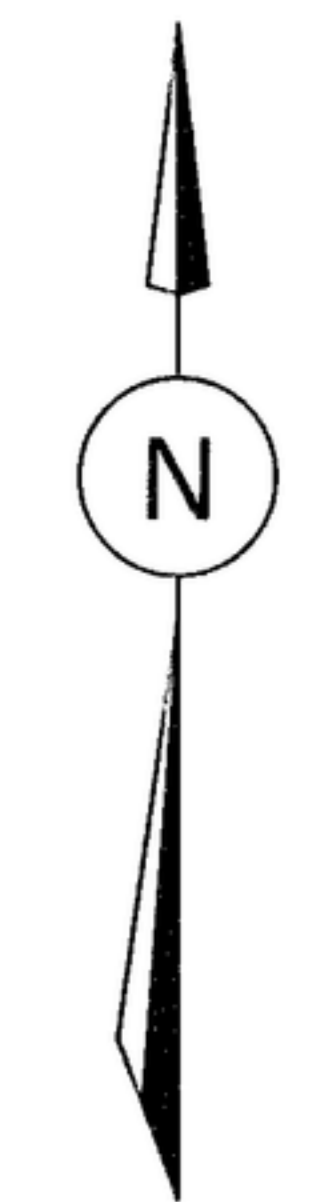


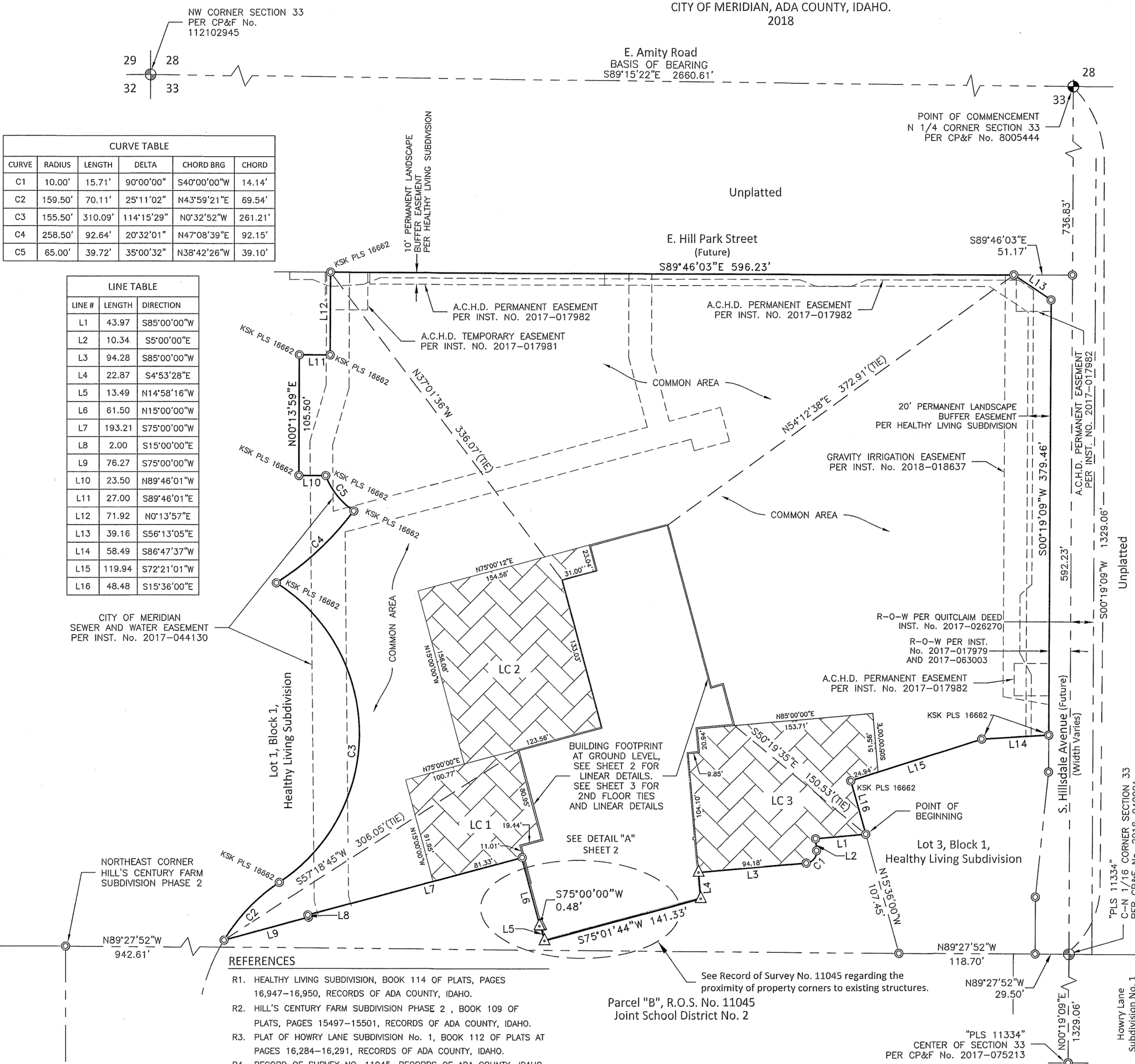

NOTES

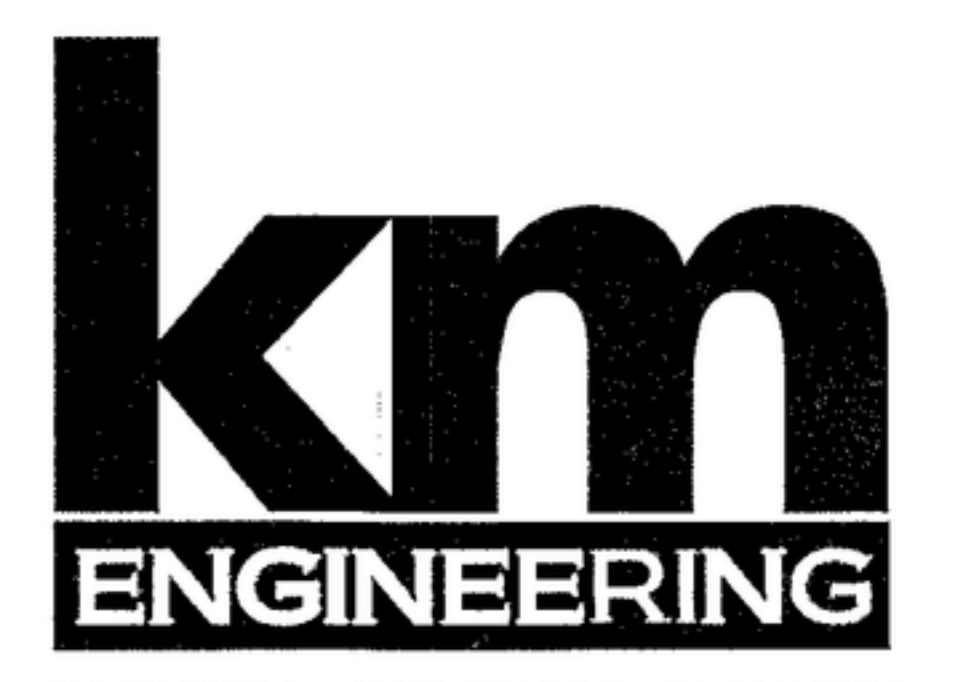
1. EACH UNIT SHALL BE CONSTRUCTED TO ALLOW EACH OWNER INGRESS AND EGRESS TO EACH OWNER'S UNIT FROM THE COMMON AREA WITHOUT PASSING THROUGH ANOTHER OWNER'S UNIT OR APPROPRIATE EASEMENTS SHALL BE GRANTED PROVIDING INGRESS AND EGRESS TO THE OWNER'S UNIT.
2. ANY AMENDMENTS TO THIS CONDOMINIUM SHALL CONFORM TO THE APPLICABLE ZONING REGULATIONS IN EFFECT AT THE TIME OF AMENDMENT, OR AS ALLOWED BY CONDITIONAL USE AND SHALL COMPLY WITH PROVISIONS OF IDAHO CODE TITLE 55 - CHAPTER 15.
3. COMMON AREA SHALL BE OWNED IN COMMON BY ALL OWNERS OF THE CONDOMINIUMS AND NO OWNER MAY BRING ANY ACTION FOR PARTITION THEREOF. EACH OWNER SHALL HAVE THE NON-EXCLUSIVE RIGHT TO USE AND ENJOY THE COMMON AREAS.
4. BUILDING SURVEY TIES AS SHOWN ARE TO THE INTERIOR CORNERS OF THE UNITS AS SHOWN. ALL UNIT LINES ARE PARALLEL OR PERPENDICULAR UNLESS OTHERWISE NOTED.
5. FOR INFORMATION CONCERNING THE USES, RESPONSIBILITIES, MAINTENANCE AND RELATIONSHIPS OF THE UNITS AND COMMON AREAS, LIMITED COMMON AREAS AND COMMON/CROSS ACCESS, INGRESS-EGRESS AND PARKING EASEMENTS, SEE THE CONDOMINIUM DECLARATIONS FOR THIS PROJECT AS FILED FOR RECORD AT THE ADA COUNTY RECORDER'S OFFICE PER INSTRUMENT No. 2018-093139.
6. THE PHYSICAL BOUNDARIES OF THE UNITS ARE AS DESCRIBED IN THE CONDOMINIUM DECLARATIONS. IN INTERPRETING THE DECLARATION, PLAT OR PLATS AND DEEDS, THE EXISTING PHYSICAL BOUNDARIES OF THE UNIT AS ORIGINALLY CONSTRUCTED OR AS RECONSTRUCTED IN LIEU THEREOF SHALL BE CONCLUSIVELY PRESUMED TO BE ITS BOUNDARIES RATHER THAN THE METES AND BOUNDS EXPRESSED OR DEPICTED IN THE DECLARATION, PLAT OR PLATS OR DEED REGARDLESS OF SETTING OR LATERAL MOVEMENT OF THE BUILDING AND REGARDLESS OF MINOR VARIANCE BETWEEN BOUNDARIES SHOWN IN THE DECLARATION, PLAT OF PLATS OR DEED AND THE ACTUAL BOUNDARIES OF THE UNITS IN THE BUILDING.
7. IRRIGATION WATER HAS BEEN PROVIDED FROM THE NEW YORK IRRIGATION DISTRICT, IN COMPLIANCE WITH IDAHO CODE 31-3805(1)(b), AS IT PERTAINS TO IRRIGATION WATER. IRRIGATION WATER WILL NOT BE PROVIDED TO THE INDIVIDUAL UNITS NOR THE LIMITED COMMON AREAS SHOWN ON THIS CONDOMINIUM PLAT. THE CONDOMINIUM ASSOCIATION WILL COLLECT ASSESSMENTS FOR SAID IRRIGATION WATER FOR THE COMMON AREAS.
8. THE COMMON AREA IS SUBJECT TO AN EXISTING ACCESS AND PARKING EASEMENT PER INSTRUMENT No. 2018-083042, RECORDS OF ADA COUNTY, IDAHO, AS MAY BE AMENDED IN THE FUTURE.
